## PROCEEDINGS OF THE MAYOR AND BOARD OF ALDERMEN TOWN OF GRAMERCY OCTOBER 14, 2019

## **PUBLIC HEARING:**

<u>ORDINANCE NO. 722-19</u> AN ORDINANCE DECLARING A CERTAIN IMMOVABLE PROPERTY AS NOT NEEDED FOR PUBLIC PURPOSES, AUTHORIZING THE DISPOSAL OF SAID PROPERTY, AND PROVIDING FOR OTHER MATTERS THEREWITH

Attorney Robert Faucheux, Jr. stated that the advertisement should include a statement that the bidder should be able to demonstrate the ability to successfully bid.

Mayor Nosacka closed the public hearing and continued with regular order of business.

#### **PUBLIC COMMENTS**

Mr. Joseph Darr, 1339, 1345, 1355 N. Airline Ave, spoke concerning Resolution No.29-19 Demolition of certain properties. He requested more time to clean up property and renovate houses.

## **PRESENTATION AND COMMENTS**

- Mayor Nosacka and the Board of Aldermen presented a proclamation to Powerlifting Champions Quamecca Stafford and Shay Naguin.
- 2. Mrs. Cathey Allen, 280 S. Mulberry Street, stated that S. Mulberry Street is a one way street yet cars are driving in both directions and asked the street to be patrolled more often. The trees across the street from her home are hanging onto the street causing the school bus to pass dangerously close to the edge of the street where the sides are collapsing; she inquired about when culverts would be replaced. S. Fir Street on E. Railroad sign is missing a One-Way sign.

## **REPORTS**

## 1. MAYOR'S REPORT

Mayor Nosacka reported the State Lead and Copper test results are in and all 20 residences were within the compliance limits. Night Out Against Crime is October 15, 2019. Ma'Jewz Eatery on E. Main Street will have a grand opening on Friday, October 18, 2019 at 11:00 am. There will be an Electronic recycle event on Saturday, October 19, 2019 in Winn Dixie parking lot.

#### 2. REPORT ON-GOING PROJECTS

Mayor Nosacka stated that the contractors for road repairs on E. Second Street will be back to finish re-surfacing in the coming weeks. Tony Arikol, Professional Engineering Consultants, reported that a larger door would be needed on the side of Dudley pump station in order to access new pumps. Meyers Engineering has provided plans for the E. Railroad location and they are available for review at town hall and the bid packets are being prepared to send out for quotes on project.

## 3. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

#### A. CHIEF OF POLICE

Police Chief Brent Dicharry stated that Night Out Against Crime is Tuesday, October 15, 2019. He recommended we follow St. James Parish and set trick or treat hours for 6:00 pm to 8:00 pm. The police department will close streets in certain areas for Halloween.

#### B. REPORT FROM EMERGENCY PREPAREDNESS

Lt. Jody Ordeneaux recommended the town residents to have their heating systems serviced and carbon dioxide detectors checked. Encouraged all to have their flu vaccinations; St. James Hospital is currently holding their Flu Shot Fair on Thursday and Friday until October 25<sup>th</sup>.

#### C. CODE ENFORCEMENT

Mr. Ronald Boudreaux reported that he continues to speak with residents concerning abandoned cars and some resident do remove the vehicles. He has currently tagged a recreational vehicle. He has spoken with the Pastor at Golden Grove Baptist Church about removing the old bus from their property.

#### 4. REPORTS FROM ST. JAMES PARISH GOVERNMENT

Mr. Alvin St. Pierre, Jr., St. James Parish District One Councilman thanked everyone for their support during his recent re-election. Budget items have been forwarded to finance and councilman for budget review. Drainage projects are included in the new budget currently under review. There is a pilot program available for installing smart water meters in unincorporated areas of the parish.

#### 5. REPORTS FROM BOARDS AND COMMISSIONS

#### A. PLANNING COMMISSION

Planning Commission Chairman Barry LeBlanc stated that he has seen progress in Mr. Darr's clean-up efforts and recommends that board give him more time to complete the job. There are 23 new home constructions in Gramercy Subdivision III located behind Taylor's Express. Recommends that town send another flyer informing the residents of permits needed in Gramercy.
