The Mayor and Board of Aldermen of the Town of Gramercy, Louisiana, met in regular, monthly session on Monday, May 11, 2020 at 7:00 p.m. via telephone conference.

REPORTS

1. MAYOR'S REPORT

Mayor Nosacka stated that Governor Edwards will lift the stay home order effective May 15, 2020; this will allow the opening of some businesses but with certain restrictions. He has begun the process of scheduling demolitions including contacting One Call to make sure all utilities have been identified and disconnected. We will be passing out red door notices to customers with past due balances on utility bills to remind customer to make a payment.

2. REPORT ON-GOING PROJECT

Mayor Nosacka reported that the water storage tank project is complete, and the tank is back in service. There are several street repairs being done through out the town. He has been in discussion with the parish concerning assistance with the finances needed for S. Millet water line relocation and installation of culverts. He has revised the scope of work to clean Ferrero Canal; with this revision the costs have been reduced, making the project more cost effective.

3. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

A. REPORT FROM CHIEF OF POLICE

Police Chief Brent Dicharry reported that his officers had to disperse two large group gatherings on Mother's Day. He is waiting for information on the plans for Governor Edward's Phase I re-opening on allowed outside activities. He will be meeting with Parish officials to consider the continued closing of all parks until further notice.

B. REPORT FROM EMERGENCY PREPAREDNESS

Lt. Jody Ordeneaux reminded residents that hurricane season begins on June 1st and now is the time to review your individual insurance policies. With two new businesses locating on LA 3125 soon the Board should consider a rain-water drainage plan to avoid worsening drainage issues.

C. REPORT FROM CODE ENFORCEMENT

Mayor Nosacka reported that he has sent several certified letters to property owners concerning abandoned vehicles.

4. REPORTS FROM ST. JAMES PARISH GOVERNMENT

District One Councilman Alvin St. Pierre, Jr. stated he has put in a work order for the cleaning of Ferrero Canal north of LA 3125. St James Parish will slowly return to normal operations.

SECTION 2. The following actions are to be implemented by the Town as necessary to maintain permit requirements contained in the LWDPS Permit Number LA0046876:

- a. Provide certified Class II operators for operation and provide sixteen (16) hours of training for each operator during the next year. This training will be conducted by the Town's environmental consultant.
- b. Operate the Pond system as recommended by the Town Engineer and Environmental Consultant and correct deficiencies and minimize permit excursions.
- c. Study and address (within Town budget limits) INI issues in the collection system.
- d. Maintain chlorination system to reduce Coliform levels.
- e. Schedule and maintain annual flow meter calibration.
- f. Contain to monitor non-domestic users and establish final non-domestic program.
- g. Continue Influent monitoring on a monthly basis.
- h. Ensure Town laboratory is following all required QA/QC documentation.

Alderman Woods received a phone call from Mr. Tim Pittman requesting more time to speak with family members concerning demolition of blighted home and to remove items from home before demolition.

Alderman Brack requested the mayor move forward with Aldermen having access to the work order program. He has received calls about the cleaning of Ferrero Canal.

Alderman Louque asked for an update on employee uniforms. Mayor Nosacka stated that the most cost-effective option would be to purchase uniforms instead of continuing to rent.

Alderman Calcagno forwarded a copy of his monthly report. He stated that revisions need to be made to the mobile home permits concerning foundation. There are several locations in Gramercy that have high grass and letters need to be mailed. We need to have a blight violation form, so the documentation is more organized. He inquired about the Mississippi River intake lights and dolphin fenders. Mayor Nosacka stated that he was in contact with an available diver that can take pictures so the engineers could design the modifications needed.

Alderman Wiggins reported he received complaints about Waste Management skipping areas on service days. The areas by S. Millet railroad needs cleaning.

TOWN ATTORNEY

Town Attorney Robert Faucheux, Jr. stated he is working on a resolution for the donation of a sewer lift station on LA 3125. He has informed Joseph Darr that he needs an occupational license to operate a business.

There being no further business it was moved by Alderman Wiggins, second by Alderman Louque, and approved to adjourn at 8:45 pm.
