RESOLUTION 25-2020

RESOLUTION TO OBTAIN SPECIAL COUNSEL FOR OPIOID-RELATED CLAIMS

WHEREAS, opioid use and issues and treatment related thereto have become a huge societal problem locally and nationally; and

WHEREAS, various entities are attempting to recover past and future damages associated with this opioid epidemic; and

WHEREAS, the Town of Gramercy, in the past years and in the future, has been and will be affected by the opioid crisis; and

WHEREAS, the Town of Gramercy should attempt to recover its damages past and future associated with this epidemic; and

WHEREAS, the Town of Gramercy wishes to retain special legal counsel; and

WHEREAS, the Town of Gramercy recommends the appointment of Leger & Shaw, Long & Long and the Law Offices of Bruce G. Mohon, LLC, and associated attorneys and paralegals. Leger & Shaw, Long & Long and the Law Offices of Bruce G. Mohon, LLC are experienced attorneys with the requisite expertise to render special counsel services and represent the Town of Gramercy regarding opioid litigation.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND THE BOARD OF ALDERMEN, TOWN OF GRAMERCY, LOUISIANA THAT:

SECTION 1. The Town of Gramercy hereby resolves that a necessity exists for the employment of special counsel, and, the Town of Gramercy, ratifies and approves the employment of Leger & Shaw, Long & Long, and the Law Offices of Bruce G. Mohon, LLC and associated attorneys and paralegals, as special counsel for the Town of Gramercy in the above described matters and to take any and all actions necessary to pursue any right or claim of the Town of Gramercy related to the opioid crisis and litigation. It is further resolved that Mayor Steven T. Nosacka is duly authorized to sign and execute any and all documents necessary including but not limited to a contingency fee retainer agreement to retain the services of the aforementioned firms and counsel. The compensation shall be in accordance with the Attorney General's opioid fee schedule.

1. MAYOR'S REPORT

Mayor Nosacka reported that several culvert repairs or replacement jobs have been completed. The maintenance crew continues clearing ditches and culverts. He will schedule the concrete failure repairs on E. Eighth Street and E. Tenth Street.

2. REPORT ON-GOING PROJECT

Mayor Nosacka stated that work on the E. Railroad Relocation Project should be completed by August 17th and he will schedule a dedication ceremony for Saturday, August 20th. We have received bids for the Dudley pump station backup generator. He asked Scott Poirrier, Hightide Consultants LLC, to provide preliminary plans for the building enlargement at Dudley pump station and to review and provide recommendations for the S. Millet water and sewer line relocations.

3. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

A. REPORT FROM CHIEF OF POLICE

Chief Dicharry reported on incident of retaliation in Gramercy connected with current events happening in Lutcher. The subjects turned themselves in two day later and the case is closed.

REPORT FROM EMERGENCY PREPAREDNESS

Lt. Jody Ordeneaux stated that with the hurricane season upon us, the town should continue their work on drainage concerns. The area by the culvert on N. Pine Street and LA 3125 is beginning to show signs of erosion.

B. REPORT FROM CODE ENFORCEMENT

Code Enforcement Officer Ronald Boudreaux continues to tag abandon vehicles and check for building permits on residential projects.

4. REPORTS FROM ST. JAMES PARISH GOVERNMENT

Councilman Alvin St. Pierre, Jr. reported that the request for \$25,000 assistance on the S. Millet utility line relocation project is on the Fireman's Association meeting agenda. Entergy has announced that a more permanent structure to help prevent flooding will be constructed by the sub-station on US 61. The Parish should begin work on Central Canal in the near future. Corp of Engineers has come out with a new levee alignment plan and will move towards approval of these plans. The Parish is willing to help with spraying Ferrera Canal.

Mr. Craig Calcagno passed out his monthly report. The parks are in good condition.  - (2) Large Commercial / Industrial 40% of total annual debt service

He inquired when Central Canal bank repairs will be performed. He has noticed that some blighted properties have high grass and property owners should be notified to mow the lawn. He asked when we will be able to install the water level gauges.

Alderman Wiggins reported that the street sign by Home Hardware needs to be replaced. He asked the Mayor to clean the ditches and culverts on S. Millet.
