#### **PUBLIC HEARING:**

<u>RESOLUTION 07-2021</u> A Resolution approving a special exception of Appendix A Zoning, Article 18, R-1 Residential District, Section 18.4 Area Regulations to allow for the variance of the minimum 5 feet distance requirement

The Mayor and Board of Aldermen of the Town of Gramercy, Louisiana, met in regular, monthly session on Monday, June 14, 2021 at 6:00 pm at Gramercy Town Hall.

## **REPORTS**

#### 1. MAYOR'S REPORT

Mayor Nosacka reported that during the backwater events a few weeks ago our maintenance crew worked hard to prevent flooding near the back end of N. Airline Avenue. Café Perique' on Main Street has been making improvements to the front of their building and it is a definite improvement. He also was notified by Good Housekeeping store owner that he is in contact with an interested buyer. Mr. Freddie Allen approached Mayor Nosacka about implementing a Main Street program that was originally suggested by town attorney Mr. Bobby Faucheux. There was a fire hydrant leak that resulted in a boil order advisory for the area south of the railroad track; the order was lifted after we received notice from Department of Health that test results were good. There was a small chlorine leak by the water plant. Mayor Nosacka contacted our chemical vendor who brought in a company to safely remove the threat. Mayor Nosacka thanked the Parish EOC for the assistance during this event. We will begin advertising for two maintenance positions beginning with the June 17<sup>th</sup> edition of the News Examiner. On Saturday, June 19, 2021 there will be a Juneteenth Celebration by New Zion Christian Center on Main Street from 12 noon to 6:00 pm, all are welcome to attend.

# 2. REPORT ON-GOING PROJECT

The Ellis Street drainage repair project may need to include swales according to DEQ regulations, our engineers are looking into this requirement. Several repairs are needed on Central Canal between 2<sup>nd</sup> and 4<sup>th</sup> Street. Mr. Bobby Faucheux has prepared the Right of Way agreement for S Millet and S Ezidore property owners so the town can dig a swale to help drain the water. There are several asphalt repairs needed in town. Scott Poirrier, Hi-tide Consultants, has received quotes for the bulkhead by Dudley Pump Station. We will advertise bids for the N Airline Pump Station project in July. He has met with Parish officials to schedule work on the S. Millet Improvement project. He is waiting on the results of smoke testing on Tania Street.

WHEREAS, the St. James Parish School Board and the St. James Parish Council have had an agreement for the cooperative collection of the sales and use taxes levied by the St. James Parish School Board and the St. James Parish Council within the corporate limits of the Town of Gramercy; and,

WHEREAS, the Town of Gramercy has passed Ordinance Number 705-18 which levies an additional one-half of one percent (.5%) sales and use tax effective July 1, 2018 within the Town of Gramercy, State of Louisiana; and.

WHEREAS, it is in the best interest of the Town of Gramercy, its merchants, citizens and taxpayers that said agreement is executed:

A RESOLUTION TO APPROVE A COOPERATIVE ENDEAVOR AGREEMNT BETWEEN ST. JAMES PARISH AND THE TOWN OF GRAMERCY FOR ROAD REPAIR/OVERLAY IN THE TOWN OF GRAMERCY

WHEREAS, the purpose of this agreement is to establish a Cooperative Endeavor Agreement between the Parish and the Town for road repair/overlay in the Town of Gramercy; and,

WHEREAS, the Parish will provide the following funding for road repair/overlay in the Town in the amount of \$75,000 in the calendar year 2021; and,

WHEREAS, the Town agrees to spend the \$75,000 only for road repair/overlay within the incorporated areas of the Town before December 31, 2021; and,

WHEREAS, this agreement constitutes the entire agreement between St. James Parish and the Town of Gramercy.

NOW, THEREFORE IT BE RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF GRAMERCY, THAT:

Section 1. Mayor Steven T. Nosacka, is hereby authorized to enter into a Cooperative Endeavor Agreement with St. James Parish for the funding of road repair/overlay within the Town of Gramercy.

A RESOLUTION ENTERING INTO AN AGREEMENT WITH SOUTH CENTRAL PLANNING AND DEVLEOPMENT COMMISSION TO ASSIST IN THE IMPLEMENTATION OF THE 2021 VOTING DISTRICTS REDISTRICTING PLAN

WHEREAS, the South Central Planning and Development Commission ("SCPDC") will prepare, coordinated the enactment, obtain pre-clearance from the U.S. Department of Justice, and assist in the implementation of the 2021 Voting Districts Redistricting ("2021 Redistricting") Plan;

WHEREAS, SCPDC will consult and meet with redistricting committee/Town Council to discuss the nature of the project, to identify problem areas, and to clarify the approaches and policies to be considered during the redistricting process.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN, TOWN OF GRAMERCY, THAT:

SECTION 1. South Central Planning and Development Commission and the Town of Gramercy hereby enter into an agreement to coordinate the enactment and obtain pre-clearance from the U.S. Department of Justice, in the implementation of the 2021 Redistricting Plan.

SECTION 2. That, Steven T. Nosacka, Mayor, is hereby authorized and empowered to sign all documents pertaining to the 2021 Redistricting Plan.

#### **ALDERMEN'S REPORT**

Alderman Calcagno passed out his monthly report. He turned in a revised building permit application for review. The new application makes the permit holder aware of required inspections. He thanked Jim Zeringue for mounting the Town map under plexiglass for the Town Hall lobby. He inquired about Bellsouth ensuring the interigty of the telephone poles. Mayor Nosacka spoke with a representative and they have no plans to do any inspections at this time. We need to remove the raised curbing by Super Ten on Main Street, it is a tripping hazard.

Alderman Wiggins thanked the town maintenance crew for the work on repairing the fire hydrant on S. Elm Street. He Thanked Knob for helping with removing a large piece of plywood in the ditch near the mobile home park.

Alderman Woods reported she received a phone call concerning loud music on S. Mulberry Street. She inquired about a sign being placed in the area.

Alderman Louque thanked the mayor for getting the damaged canopy by Valero station removed before there were any injuries.

Alderman Brack reported a fire hydrant leaking by 308 E. Airline Highway. The sewer lift station near Sonic continues to overflow. Mayor Nosacka stated a new switch panel is on order.

### **TOWN ATTORNEY**

Mr. Faucheux reported that he and Mayor Nosacka will meet with Attorney Scott Thomas concerning the Rise St James lawsuit.

There being no further business it was moved by Alderman Wiggins , second by Alderman Brack, and approved to adjourn at 7:24 pm.
