PROCEEDINGS OF THE MAYOR AND BOARD OF ALDERMEN TOWN OF GRAMERCY AUGUST 14, 2023

The Mayor and Board of Aldermen of the Town of Gramercy, Louisiana, met in regular, monthly session on Monday, August 14, 2023 at 6:00 pm at Gramercy Town Hall.

Mayor Bourgeois called the meeting to order, and asked the Clerk to call roll:

PUBLIC COMMENTS - There were no comments made on agenda items.

PRESENTATION AND COMMENTS

Rosette Moses, 720 N Magnolia Street, expressed her concerns about a streetlight near her home that has been out since November 2022. She called Entergy for a repair, and they advised her that it was the town's responsibility to repair. She called the town hall and as of this date it is not repaired. Mayor Bourgeois stated that he has issued a purchase order for the repair of several streetlights in town including the one by her home.

REPORTS

1. MAYOR'S REPORT

Mayor Bourgeois stated that he has turned into the LA Dept of Agriculture a management plan for the vegetation debris by the old sewer pond. There will be a construction kick off meeting with Professional Engineering Consultants and contractors for the Sewer Force Main Project on Friday, August 18, 2023 at 10:00 am. He walked out the road panel repair project on E. Eighth Street and N. Montz Street so we can advertise proposals in the near future.

REPORTS OF DEPARTMENT HEADS AND DIRECTORS

A. REPORT FROM CHIEF OF POLICE

Mr. Brent Dicharry, Chief of Police, reported that the officers have begun using the new Ecitation handhelds and they have said the process for issuing a citation is now more efficient. He issued a report showing the number of tickets and the location of where each ticket was written. He stated that a kick-off meeting with the Baton Rouge SPCA was held concerning a parish shelter and they will hold more meetings in the future.

REPORT FROM EMERGENCY PREPAREDNESS - There is no report for this month.

REPORT FROM CODE ENFORCEMENT

Sgt. Gerhold turned in his monthly report. He reported that only two vehicles have been removed by property owners and he added several more to the list.

REPORTS FROM ST. JAMES PARISH GOVERNMENT - There is no report for this month.

2. REPORTS FROM BOARDS AND COMMISSIONS

Commission Member Alex Gerhold reported that the commission met with Tony and Charmaine Siciliani, 423 E. Jefferson Highway, concerning a fence permit. They are restoring the Dr. Ezidore home and want to put a 5-foot fence in the front yard to preserve the historical representation of the home. The commission recommended they apply for a variance of the town's fence ordinance. A public hearing has been set for September 11, 2023 concerning the variance request. Mr. Dean Millet presented a survey of property for re-subdivision. The commission has asked for more information.

RESOLUTION NO. 30-2023

A RESOLUTION AUTHORIZING THE MAYOR TO SIGN AN OPT-IN FORM FOR THE STATE-MANAGED TEMPORARY HOUSING PROGRAM UNDER LOUISIANA REVISED STATUE 726(F)(3)(B)(iii)(aa)

WHEREAS, Act 526 (HB 1070) of the State of Louisiana 2022 Legislative Session requires each jurisdiction to Opt-In or Opt-Out of the temporary housing and shelter assistance program that is managed by the Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP); and

WHEREAS, the Town of Gramercy desires to Opt-In to the GOHSEP program for Town residents; and

WHEREAS, an Opt-In to the GOHSEP temporary housing programs have no effect on any of the Federal or FEMA temporary housing and shelter assistance programs; and

WHEREAS, an Opt-In does not provide any approval for group or large site development.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN, TOWN OF GRAMERCY, LOUISIANA, THAT:

SECTION 1. Mayor Steven J. Bourgeois is hereby duly authorized and empowered on behalf of the Town of Gramercy, to sign and execute an Opt-In form as required by Act 526 (HB 1070) of the State of Louisiana 2022 Legislative Session.

RESOLUTION NO. 31-2023

A RESOLUTION APPROVING THE ANNUAL LOUISIANA COMPLIANCE QUESTIONNAIRE FOR AUDIT ENGAGEMENTS OF GOVERNMENT AGENCIES

WHEREAS, the Louisiana Legislative Auditor requires the preparation of an annual Compliance Questionnaire for Audit Engagements of Government agencies, and;

APPROVAL OF MINUTES

PAYMENT OF BILLS

Mayor Bourgeois asked for approval of bills. A motion was moved by Alderman Brack, second by Alderman Louque and approved to pay all bills and accept financial statements presented before the Council.

ALDERMEN'S REPORT

Alderman Brack stated his questions concerning streetlight repairs had been answered during the meeting.

Alderman Louque reported he has spoken to Sgt. Gerhold concerning a property on N. Airline Avenue with an abandoned vehicle, accumulated debris, and high grass.

Alderman Williams stated he received a complaint concerning the high grass and abandoned building by New Zion Christian Center property on E. Second Street. A high-grass letter needs to be sent to the property owner at 244 S Sycamore. He will forward the addresses of several streetlights in Golden Grove subdivision that need repair.

Alderman Wiggins thanked the maintenance crew for quickly repairing the water leak on S. Hickory Street. He reported vagrants are living in an empty house on S. Plum Street.

Alderman Calcagno passed out his monthly report. He reported to the police department about vendors going to houses without a permit. He spoke with them, and they didn't know the hours allowed. Streetlight surveys have been routine and reported as normal, however, repairs are not getting done in a timely manner. Main Street has qualified for overlay and outfall repairs by Department of Transportation.

TOWN ATTORNEY

Mr. Faucheux reported that he received documents concerning the Police Chief retirement fund that need to be signed by the Police Chief and Mayor. There has been no progress on repair or remodeling of the property on S. Airline Avenue. He has sent a request to remove the restraining order for property.

There being no further business it was moved by Alderman Wiggins, second by Alderman Williams and approved to adjourn at 6:44 pm.
