## PUBLIC COMMENTS

No public comments were received on agenda items.

#### PRESENTATION AND COMMENTS

Mr. Mike LeBlanc, Postlethwaite and Netterville, presented the financial statements for the fiscal year ending June 30, 2018.

Ms. Alicia Butler, 219 S. Elm Street, expressed concerns about E. Railroad Avenue still being closed to through traffic and inquired if the railroad crossing arm can be removed. Ms. Butler stated that the intersection of E. Main Street and S. Millet is a traffic hazard when cars are parked by the stores it is extremely difficult to see oncoming traffic. She asked the Mayor and Board of Aldermen to research solutions to this problem.

## REPORTS

## 1. MAYOR'S REPORT

Mayor Nosacka reported that the latest communication from AT&T on moving their lines on S. Airline is the engineering plans have been turned into the Department of Transportation for approval. The Mayor will move forward with the clean-up and repair of the access way in the rear of Taylor's Express. He will be coming forward with an infrastructure priority list for review for the next year. The Dudley Pump Station bid opening has been moved to February 7, 2019 at 10:00 am. A meeting with the Krewe of MAC will be held on January 25, 2019 at 8:00 am to discuss the upcoming Mardi Gras parade. The monthly report from the Sales Tax office has been provided to show the current amount of taxes being collected.

## **REPORT ON-GOING PROJECTS**

The date to receive bids for the Dudley Station rehabilitation has been postponed until February 7, 2019 due to an addendum by the engineers.

#### 2. REPORTS OF DEPARTMENT HEADS AND DIRECTORS

#### A. CHIEF OF POLICE

Chief Brent Dicharry reported that traffic for Christmas Eve was heavy and he is already working on plans for Christmas Eve 2019 to have town streets open for emergency vehicles. He will be meeting with Sheriff Martin to discuss safety concerns with the upcoming Mardi Gras parade. He advised the Board that his officers will resume code enforcement on abandoned vehicles.

## B. REPORT FROM EMERGENCY PREPAREDNESS

Director Jody Ordeneaux stated that the Mississippi River is expected to crest on January 19-21, 2019. With the upcoming freeze expected, now is the time to take precautions such as wrapping pipes. The citizens of Gramercy should be encouraged to conserve water.

## 3. REPORTS FROM ST JAMES PARISH GOVERNMENT

District One Councilman St. Pierre reported that the FY budget for the Parish has been approved. The Town will receive \$75,000.00 for road improvements. St. James Parish administration will be coming forth with a proposed drainage sales tax; more information will be provided for the public to understand the need and purpose of this tax. There will be new industry coming to St. James Parish which will provide employment opportunities for qualified parish residents.

## 4. REPORTS FROM BOARDS AND COMMISSIONS

#### A. PLANNING COMMISSION

Chairman Barry LeBlanc reported that there has been no new communication concerning the proposed RV Park on E. Airline Highway.

## B. GRAMERCY RECREATION DISTRICT

Mr. Craig Calcagno passed out his monthly report. It was suggested to use Pole Barn Construction for the future press box. The master plan may include installation of baseball field lighting and drainage. The Parish School Board is still undecided about using the pool for swim practice. Requested the Parish use dump trucks to haul slag to East parking lot.

The attached estimate of revenues as reflected in the supporting line-item budget, and such other fiscal exhibits and information as required by Section 1308(D) Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the Amended Budget of Revenues of the Sales Tax Fund for the Town of Gramercy, Louisiana, for the fiscal year ending June 30, 2019.

SECTION II. The attached detailed statement of expenditures as reflected in the supporting line-item budget, and such other fiscal exhibits and information as required by Section 1308(D) Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the Amended Budget of Expenditures of the Sales Tax Fund for the Town of Gramercy, Louisiana, for the fiscal year ending June 30, 2019

SECTION III. The adoption of the Amended Budget of Expenditures reflected in the attached line-item budget containing account object of expenditures classifications shall be declared to be the appropriation of the amounts set therein as established in each budget classification by object of expenditures.

SECTION IV. The amount appropriated for all accounts shall not exceed the amounts fixed therefore in the Amended Budget of Expenditures. Nothing contained in this section shall be construed to prohibit the governing authority from amending or making appropriations to, and for the contingent fund to be used in cases of emergency.

SECTION V. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION VI. If any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items, or applications, and to this end the provisions of this ordinance are hereby severable.

WHEREAS, the Town has publicly solicited bids for the renovation services, with Gatorphant Industries, LLC determined to be the lowest responsible bidder for these services; and

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND THE BOARD OF ALDERMEN, TOWN OF GRAMERCY, LOUISIANA THAT:

SECTION 1. Steven T. Nosacka, Mayor, is hereby authorized to execute the Contract with Gatorphant Industries, LLC for renovations to the interior of the Montz Avenue Fire Station, and to submit the expenditures for reimbursement by the State as required by the Contract.

#### PAYMENT OF BILLS/FINANCIAL STATEMENTS

It was moved by Alderman Wiggins, second by Alderman Louque, and approved to pay all bills and accept financial statements presented before the Council.

#### ALDERMEN'S REPORT

Alderman Wiggins reported that new stops signs are needed in several areas of town. Blighted properties are still a concern and he encouraged the mayor to continue to identify these properties. He welcomed Alderman Brack and Alderman Louque to the Board.

Alderman Betty Coleman reported that several property owners have pools that are not properly fenced in. She welcomed Alderman Brack and Alderman Louque to the board and looks forward to working with them. She inquired if the mayor had any ideas for use of the repaired N. Montz fire station.

Alderman Louque stated that there are several sinking culverts in Gramercy Park subdivision, Phase II that need repair. He suggested that flexible markers be placed by Roussel's Antiques on E. Main Street to prevent parking on the corner that blocks the view of traffic coming out by S. Millet.

Alderman Darren Brack thanked the voters of District Two for electing him as Alderman. He thanked Jody Bourgeois for his eight years of service to the town. Reported the speed bump in second block of N. Montz needs to be repaired. There is a sink hole by 495 N. Pine Street near the telephone pole that needs to be repaired.

Alderman Calcagno passed out his monthly report. With the Mississippi River high levels the maintenance crew received permission from the Ponchartrain Levee Board and Corps of Engineers to complete a water line repair; he thanked the Levee Board and Corps of Engineers for their quick response. He has started reviewing the Town's blighted property ordinance and there are several improvements that can be made. The concrete street, 14<sup>th</sup> Street at Ezidore Canal, has failed in the culvert area. He thanked Clyde for his continued efforts to clean Main Street.

## ATTORNEY'S REPORT

Town Attorney Mr. Robert Faucheux, Jr. stated that he filed an exception for the town concerning the Nolan Carmouche litigation. The town will go back to 23<sup>rd</sup> Judicial Court concerning Thomas Ragas in March 2019 and Cleveland Parquette in May 2019. Chief Dicharry has gone through several hours of deposition concerning a case the police department was involved in the summer of 2018; at this time no filing has been made against Gramercy.

There being no further business it was moved by Alderman Wiggins, seconded by Alderman Brack, and approved to adjourn at 8:55 pm.
