PROCEEDINGS OF THE MAYOR AND BOARD OF ALDERMEN TOWN OF GRAMERCY APRIL 11, 2022

The Mayor and Board of Aldermen of the Town of Gramercy, Louisiana, met in regular, monthly session on Monday, April 11, 2022 at 6:00 pm at Gramercy Town Hall.

Mayor Nosacka called the meeting to order, and asked the Clerk to call roll:

PUBLIC COMMENTS - There were no public comments.

PRESENTATION AND COMMENTS -

Earline and Terrance Hayes, owners of Ma'Jewz Restaurant, 234 E Main Street, asked the Mayor and Board of Aldermen to consider issuing an alcohol license for their restaurant. Mayor Nosacka asked to meet with the owners to discuss their business plan for the restaurant.

REPORTS

1. MAYOR'S REPORT

Mayor Nosacka stated the Town of Gramercy trash day will coincide with St. James Parish and State's Anti-Litter wee on Saturday, April 23, 2022. FEMA reimbursement work continues, with biweekly conference calls and providing backup documentations. The Town has received initial reimbursement payment.

2. REPORT ON-GOING PROJECT

Mayor Nosacka reported that the concrete street repair request has been submitted to FEMA and is schedule for review. We are waiting on the Contractor's scheduling for asphalt street repairs. We are waiting on engineering plans and costs estimates for S. Millet Avenue, Central Canal, Lighting Project on 3125, and Sportsman Pond Access Road lift projects. We are awaiting bids for the N. Ezidore Circle Drain Culvert upgrade project.

REPORTS OF DEPARTMENT HEADS AND DIRECTORS

A. REPORT FROM CHIEF OF POLICE

Chief Dicharry reported that the investigation on the Mobile Lane shooting is still under investigation.

B. REPORT FROM EMERGENCY PREPAREDNESS

There was no report for this month.

C. REPORT FROM CODE ENFORCEMENT

Code Enforcement Officer Alex Gerhold passed out a monthly report. He has tagged about 50 vehicles; 12 have been moved by owner. He has sent certified letters to owners he has not be able to personally speak with.

RESOLUTION NO. 21-2022

A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT PROPOSAL FOR AUTOMATIC METER READING PROJECT

WHEREAS, the Town of Gramercy has determined the need to install Automatic Meter Reading (AMR) equipment for a portion of the Town's utility meters; and

WHEREAS, the Town of Gramercy has publicly advertised and solicited proposals from contractors to perform this work.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN, TOWN OF GRAMERCY, LOUISIANA, THAT:

ALDERMEN'S REPORT

Alderman Woods stated she has received calls about the tall grass at 1557 E. Second Street and she has spoken with a family member to have the grass cut.

Alderman Wiggins reported a letter needs to be sent to property owner on Tulip Street for tall grass. The windsock at the water plant still needs to be replaced. He reported to Chief Dicharry of speeding complaints he received on S. Fir Street and N. Montz Street.

Alderman Calcagno passed out his monthly report. He thanked Alex Gerhold for the code enforcement monthly reports. He inquired what is the next step of action on Hurricane Ida damaged structures; would they be eligible for the PPDR program? He discussed his concerns about the recent gun violence in Gramercy. These shootings do not affect only the parties involved but surrounding residents and their properties.

TOWN ATTORNEY

Mr. Faucheux stated that the settlement conference for Rise St. James lawsuit is scheduled for May 2, 2022 and asked the Aldermen to review comments that the town will bring before the magistrate.

There being no further business it was moved by Alderman Wiggins , second by Alderman Calcagno, and approved to adjourn at 7:13 pm.
