PROCEEDINGS OF THE MAYOR AND BOARD OF ALDERMEN TOWN OF GRAMERCY APRIL 9, 2018

PUBLIC COMMENTS - No comments were received on agenda items.

PRESENTATION AND COMMENTS - None

REPORTS

1. MAYOR'S REPORT

Mayor Nosacka stated that the Entergy Franchise Agreement review is nearly complete. He thanked the citizens of Gramercy for their support of the Sales & Use Tax. We have not reached an agreement on the price of 600 square feet of property needed for the E. Railroad Project; therefore we will file an expropriation suit for the property. Mayor Nosacka suggested that we consider using a different engineer on street projects that will use sales tax funds. St. James Parish is currently cleaning out the Hot Water Canal and Central Canal to help with drainage. The mayor has received a proposal from A3M Services on culvert cleaning in Park A. During the summer, the town will begin a project to install culverts that will divert water from Central Canal to Golden Grove Canal. Alderman Rhonda Lee asked for an update on the fire victims; Mayor Nosacka reported that there were no injuries and he has been in contact with the land owners to begin the demolition of the ruined structures. Police Chief Dicharry thanked Todd Washington, Tory Burnett and Dwayne "Choupique" Joseph for assisting an elderly lady safely get out of the mobile home that was destroyed by the fire.

REPORTS OF DEPARTMENT HEADS AND DIRECTORS

A. CHIEF OF POLICE

Chief of Police Brent Dicharry stated that he is interested in bringing back the auxiliary program. The mayor requested a cost estimate for each auxiliary officer in the program to be presented at the May meeting.

B. EMERGENCY PREPAREDNESS

Lt. Jody Ordeneaux reported that the move of the Town Hall Administration Office to the Police Department went smoothly.

CODE ENFORCEMENT

Mayor Nosacka reported that three houses were demolished in March. Mr. Ragas has stopped working on his building and the mayor would like to have the remaining demolition done by a contractor.

PLANNING COMMISSION

Planning Commission Chairman Barry LeBlanc reported that he noticed several residents did not have a building permit to do work on their homes. If any aldermen or police officers notice work being done, please contact the town hall or him so the issue can be looked into.

GRAMERCY RECREATION BOARD

Mr. Calcagno passed out his monthly report. Mr. Calcagno stated that the Pool A will be open to the public this summer. Improvements to Park B include an ADA water fountain and bench with concrete slab.

ORDIANACE – FIRST READING

ORDINANCE 705-18 An ordinance providing for the continued levy within the Town of Gramercy, State of Louisiana, effective July 1, 2018, of a one-half of one percent (1/2%) sales and use tax (the "Tax") upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and upon the sale of services in said Town and for the assessment, collection, payment thereof and the dedication of the proceeds of said Tax and the purpose for which the proceeds of the Tax may be expended, said Tax having been authorized at a special election held in the Town on March 24, 2018.

SECTION 3. <u>Promulgation of Election Result.</u> The result of said election shall be promulgated by publication in the manner provided by law.

Montz Avenue, Gramercy, Louisiana, the Mayor and Board of Aldermen of the Town of Gramercy, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Town of Gramercy, State of Louisiana (the "Town"), and being the authority ordering the special election held therein on Saturday, March 24, 2018, with the following members present:

Shall the Town of Gramercy, State of Louisiana (the "Town"), under the provisions of Article VI, Section 29 of the Louisiana Constitution of 1974, and other constitutional and statutory authority, be authorized to levy and collect a tax of one-half of one percent (1/2%) (the "Tax") in perpetuity, from and after July 1, 2018, upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the Town, all as defined by law (an estimated \$300,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), with the proceeds of the Tax (after paying the reasonable and necessary expenses of collecting and administering the Tax), to be dedicated and used for constructing, improving, extending and maintaining streets, drainage, sewer infrastructure and sewerage treatment works; police department equipment; and purchasing and acquiring the necessary equipment and land for any of the aforesaid public works, improvements and facilities?

There was found by said count and canvass that there was a total of **247** votes cast **IN FAVOR OF** the Proposition and a total of **110** votes cast **AGAINST** the Proposition, as hereinabove set forth, and it was further found and determined that there was a majority of **137** votes cast **IN FAVOR OF** the proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Proposition as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the Town on Saturday, March 24, 2018.

Alderman Lee thanked the town maintenance crew for repairing the sink holes in front of her father's yard. She stated that there will be plenty of activity at the schools this summer due to the grade transitions for the elementary schools.

Alderman Bourgeois thanked St. James Parish for assistance with cleaning drainage ditches. He thanked Rhonda Colar for her continued work on getting street light repairs done in a timely manner.

Alderman Calcagno passed out his monthly report. Alderman Calcagno stated that he noticed several abandoned cars were tagged and towed. He feels that our blighted home ordinance is in need of updating. He reported that several potholes need repair on Main Street. On March 31, 2018, Noranda had another white dust release; spoke with Jim in Noranda's Environmental Department but feels Noranda is not doing enough to prevent the releases.

Mayor Nosacka recognized Louisiana Sugar Refinery for their continued efforts to solve the citizen's odor concerns. He has noticed work being done by the pond.

TOWN ATTORNEY REPORT

Mr. Faucheux reported that on May 14, 2018, the town goes before the Judge to dissolve the restraining order on the Parquette mobile home. He will be filing the suit for expropriation of a portion of land owned by United Food and Commercial Workers Union. We have received an Attorney General opinion concerning drainage maintenance statues.

There being no further business it was moved by Alderman Lee, second by Alderman Calcagno and approved to adjourn 8:30 pm.
